A RESOLUTION APPROVING THE MAXIMUM PROPERTY TAX DOLLARS
REQUESTED FOR FISCAL YEAR JULY 1, 2022 – JUNE 30, 2023

WHEREAS, at the January 12, 2022 regular city council meeting, the Lawton City Council approved setting a public hearing for February 9, 2022, on the maximum property tax dollars requested, and

WHEREAS, notice of said hearing was published as required in the Movable Record on February 27, 2022, and posted on the City website and social media account, and

WHEREAS, said hearing concerning the proposed city maximum property tax dollars was held on February 9, 2022, and

WHEREAS, the City Council of the City of Lawton have considered the proposed FY2022/2023 maximum property tax dollars for the affected levy total, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lawton, Iowa, that the maximum property tax dollars for the affected tax levies for FY 2022/2023 shall not exceed the following total:

The Maximum Property Tax dollars requested in the total maximum levy for affected property tax levy for the FY 2022/2023 does not represent an increase of greater than 102% from the Maximum Property Tax dollars requested for FY 2021/2022.
